Yates Petroleum Corporation respectfully requests administrative approval to amend the captioned commingling order, a copy of which is attached, to include the following well:

Ross IZ Com #1
1980' FNL & 1980' FWL (SENW)
Section 28-T19S-R25E
Eddy County, New Mexico
Fee Lease

The production from this well will be commingled with the production from the Hinkle ALD #1 and the Patriot AIZ #5. The production will be transported prior to measurement to a common tank battery located at the Hinkle ALD #1. A map labeled Attachment I is enclosed for your information.

The purpose of this off-lease storage and surface commingling is to reduce operating costs for storage and treating, thereby extending the economic life of each well. Without approval for utilizing existing batteries on adjacent leases, it will become necessary to build separate facilities for each well. This will greatly increase costs and shorten the economic life of the wells.

Because working interests for the wells are different, oil from each of the wells will be measured by positive displacement, temperature compensated metering equipment prior to surface commingling. Gas from the wells will also be metered separately. This metering will ensure that all production from each of the wells is equitably accounted for with no significant effect on your revenue. The production is from the same producing zone which is the Canyon.
