Description: N/2 of Section 4, Township 19 South,

Lease: Samuel Burns '34' State Lease
Description: N/2 of Section 34, Township 18 South,

Lease: W.B. Travis '15' State Lease
Description: E/2 of Section 15, Township 18 South, and;

Lease: James Garvin '22' State Lease
Description: S/2 of Section 22, Township 18 South, and;

Lease: George Pagan '26' State Lease
Description: W/2 of Section 26, Township 18 South, and;

Lease: J. Guerrero '34' State Lease
Description: S/2 of Section 34, Township 18 South, and;

Lease: Edward Mitchusson '4' State Lease

all located in Range 28 East, NMPM, Eddy County, New Mexico.

Production shall be allocated to each lease by separately metering the production from each prior to commingling.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 303 of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.



REMARKS: The commingled production shall be stored in the Buchanan No.1 tank battery facility located in Unit Letter 'I', Section 33, Township 18 South, Range 28 East, NMPM, Eddy County, New Mexico.

FURTHER: The operator shall notify the Artesia district office of the Division prior to implementation of the commingling process.

PROVIDING: Validation of this authority shall be accomplished by like approval from the New Mexico Commissioner of Public Lands.
