We have received your letter of December 21, 1999, wherein you requested our approval to surface commingle the production from the subject leases. Due to a treater failure, Phillips Petroleum Company wishes to send production from the Phillips State E #3 Battery via pipeline to Leamex #8 Battery.

It is our understanding that there will be no loss of commercial value in the commingled production. Production from the subject wells will be determined by periodic well tests.

Since it appears that there will be no loss of revenue to the State of New Mexico's beneficiaries as a result of your proposed operation, your request is hereby approved. Our approval is given with the understanding that the Commissioner of Public Lands reserves the right to amend or withdraw his approval, should this operation prove to be unprofitable to the state at any time in the future. Also, our approval is subject to like approval by the New Mexico Oil Conservation Division.

Your \$30.00 filing fee has been received.






