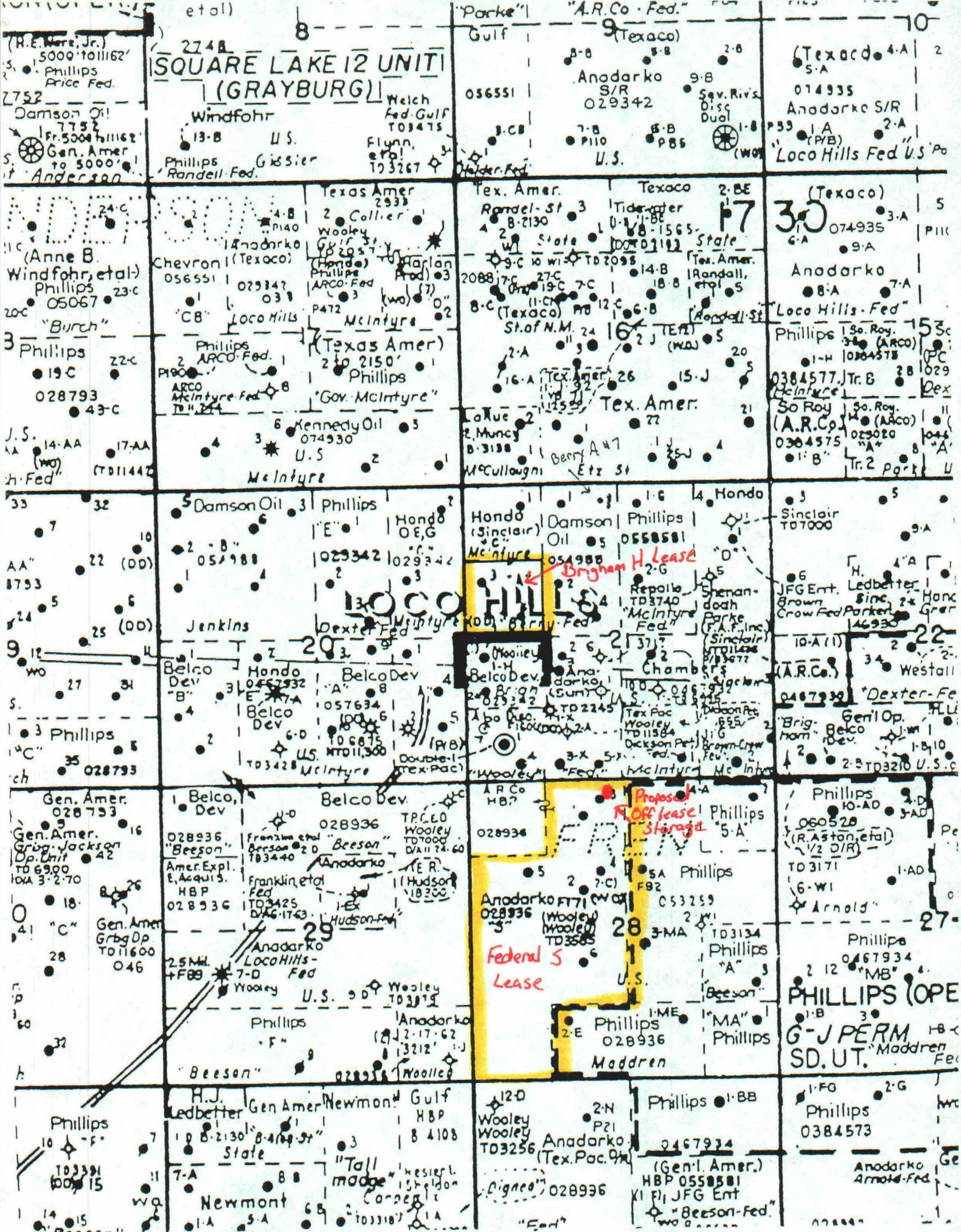

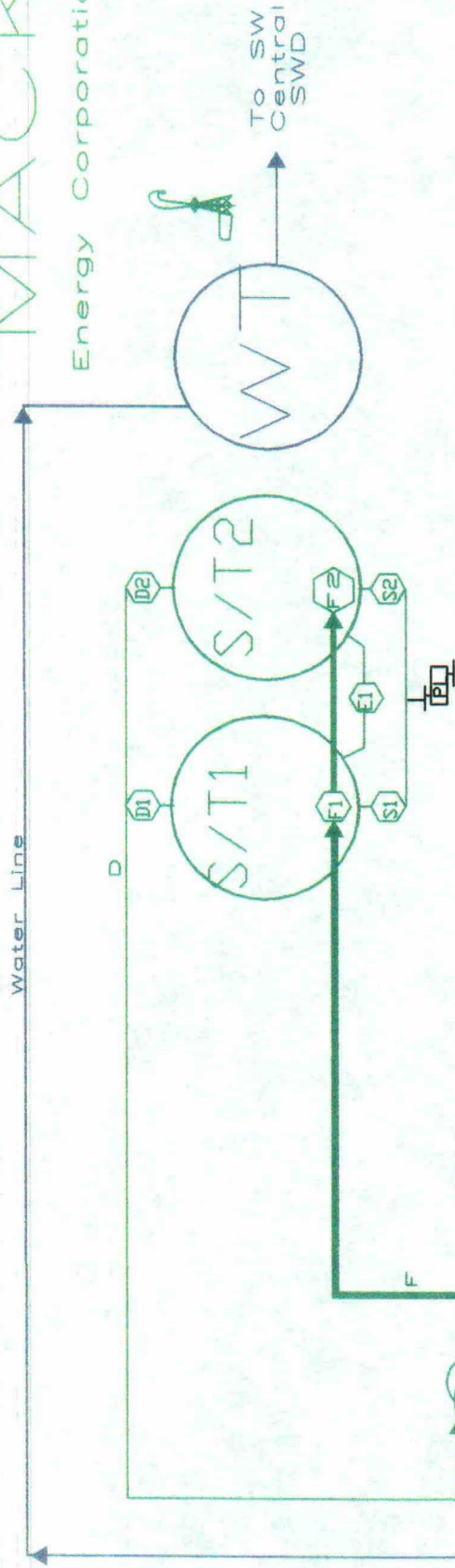
Proposed Flowline R-O-W in Green
