The production will be transported prior to measurement to a common tank battery located at the Hawkins GY #1 location. A map is enclosed for your information

The purpose of the surface commingling, and pool commingling is to reduce operating costs for storage and treating thereby extending the economic life of each well. Without approval for utilizing the existing battery located at the Hawkins GY #1 it will become necessary to build a separate facility for the Hawkins GY #4.

Because working interests for the wells are different, oil from each of the wells will be measured by positive displacement, temperature compensated metering equipment prior to surface commingling. Gas from the wells will also be metered separately. This metering will ensure that all production from each of the wells is equitably accounted for with no significant effect on your revenue. The production from the wells #1,2,3,&5 are from the Atoka San Andres zone. The Hawkins GY #4 is from the Atoka Permo Penn zone.

In accordance with the Oil Conservation Division's Rules 303-B, 309-B and 309-C, the following diagrams and maps are enclosed for your information:

- A diagram of the proposed measurement equipment, separators and storage tanks in accordance with the "Manual for Installation and Operation of Commingling Facilities".
- Notification of working interest, royalty interest and overriding royalty interest owners of the proposal to commingle production (list enclosed).


