John H. Hendrix Corporation request approval to surface pool commingle oil from the Blinebry Oil and Gas Pool (Well No. 5), Blinebry Prorated Gas (Well No. 7) and Tubb Oil and Gas Pool (Well No. 6). This is necessitated by our recent re-entering and completing Well No. 6 in the Tubb Oil and Gas Pool. These three wells and pools underly a single lease. Attached in support of this request are the following:

1. Table I showing produced volumes from each well and pool with API gravities before and after commingling.
2. Schematic diagram of facilities.
3. Plat showing location of each well.


