

Dear Mr. Carriger:

We have received your application your application requesting approval to commingle production from the State "BB", State "L" and N.M. "BZ" State NCT-10 leases. The production from the subject leases will be commingled in a common storage facility located in Unit Letter E, Section 2, Township 25S, Range 37E, Lea County, New Mexico, at the State "L" lease battery.

We understand that production from the State "BB" and State "L" leases will be metered separately from the N.M. "BZ" State NCT-10 lease.

Since it appears that there will be no loss of revenue to the State of New Mexico as a result of your proposed operation, your request is hereby approved. Any deviation from the substance of your request will be sufficient grounds for rescinding our approval. Our approval is subject to like approval by the New Mexico Oil Conservation Division.

Since the State "BB" wells and the N.M. "BZ" State NCT-10 wells are utilizing the tank battery on Lease B-1328-1, a right-of-way easement may be required for a portion of the SW/4NW/4 of Section 2-25S-37E. Please contact Ms. Debra Padilla of our Right-of-Way Section for further information regarding this easement. Ms. Padilla's telephone number is 827-5729.


Our approval is contingent upon Texaco's obtaining any required rights-of-way.
