The above-named company is hereby authorized to commingle Basin-Dakota (Prorated Gas - 71599), Blanco-Mesaverde (Prorated Gas - 72319) and South Blanco-Pictured Cliffs (Prorated Gas - 72439) Pool production from the following leases:

Lease: Rincon Unit Lateral No. 1 Tract No. 13 (Lease No. SF-079364),
Description: N/2 of Section 28,

Lease: Rincon Unit Lateral No. 1 Tract No. 14 (Lease No. SF-079365-A),
Description: All of Section 23, NE/4, NE/4 SE/4 of Section 22,

Lease: Rincon Unit Lateral No. 1 Tract No. 15 (Lease No. SF-079366),
Description: S/2 of Section 21,

Lease: Rincon Unit Lateral No. 1 Tract No. 15-A (Lease No. SF-079366),
Description: W/2 NW/4, W/2 SW/4, SE/4 SW/4, S/2 SE/4 of Section 22,

Lease: Rincon Unit Lateral No. 1 Tract No. 16 (Lease No. SF-079367-A),
Description: All of Section 26, and the S/2 of Section 27, and

Lease: Rincon Unit Lateral No. 1 Tract No. **10**,
Description: E/2 NW/4, NE/4 SW/4, NW/4 SE/4 of Section 22,

All in Township 27 North, Range 6 West, NMPM, Rio Arriba County, New Mexico.

Production shall be allocated to each lease on an mmbtu basis by multiplying the total central delivery point mmbtu by an allocation factor. The allocation factor shall be determined by dividing the individual allocation meter mmbtu by the sum of the individual allocation meter mmbtus.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: The commingled natural gas production shall be delivered to a CDP located in the NE/4 NE/4 of Section 27, Township 27 North, Range 6 West, NMPM, Rio Arriba County, New Mexico.

FURTHER: The operator shall notify the Aztec District Office of the Division upon implementation of the commingling process.

PROVIDING: Validation of this authority shall be accomplished with like approval by the U.S. Bureau of Land Management.
