Your request to surface commingle hydrocarbons from the Wolfcamp formation from both of well No. 2 on the Aztec 22 Federal lease NM-0997, and Comm well No. 3 on the Percha 15 Federal lease NM-21171, Lea County, New Mexico, is hereby approved subject to the concurrence of the New Mexico Oil Conservation Division.

Also, your request for off-lease storage from the Percha 15 Federal Com. well No. 3 to the Aztec 22 Federal Battery located in SE $\frac{1}{4}$ NW $\frac{1}{4}$, Sec. 22, T. 18 S., R. 33 E., Lea County, New Mexico, is hereby approved.

It is our understanding that proper production allocation back to these two wells will be through metered heater treater.

We understand that the working interest owners have been notified and the Federal royalty interests are identical. Further, your request is made in the interest of conservation and will not result in reduced royalty or improper measurement of production.

Federal Royalties will not be reduced as wells will be continuously metered. Both wells produce from the same Field and Reservoir and have the same gravity.

Additionally, we request off-lease storage approval from the Percha 15 Federal Com. Well No. 3 to the Aztec 22 Federal Battery located in F, Sec. 22, T-18-5, R-33-E, Lea County, N.M.

I called Mr. Pete Martinez with the Commissioner of Public Lands Office on 9-11-92 and asked Mr. Martinez if this application needed to go through the State Land office since the Percha 15 Fed Com. Well No. 3 has a communitization agreement involving state land. Mr. Martinez said because the location of the well is on Federal Land and production is going to a Federal lease that the State Land Office did not need to approve this.
