The above-named company is hereby authorized to commingle Empire South Morrow (Gas - 76400), Bear Grass Draw Atoka (Gas - 71687) and West Bear Grass Draw Atoka (Gas - 71688) Pool production from the following leases:

Lease: Empire South Deep Unit Well Nos.1 and 2 (Federal Lease No.NM-056014)
Description: SW/4 NE/4 and NW/4 SE/4 of Section 6, Township 18 South, Range 29 East, and,

Lease: Empire South Deep Unit Well No.3 (State Lease No.B-4458-33)
Description: SE/4 SW/4 of Section 31, Township 17 South, Range 29 East, and,

Lease: Empire South Deep Unit Well No.5 (Federal Lease No.NM-0555569)
Description: SW/4 NE/4, of Section 31, Township 17 South, Range 29 East, and,

Lease: Empire South Deep Unit Well No.6 (State Lease No.E-1284-3)
Description: SW/4 SE/4 of Section 1, Township 18 South, Range 28 East, and,

Lease: Empire South Deep Unit Well No.12 (Fee Lease)
Description: NE/4 SW/4 of Section 5, Township 18 South, Range 29 East, and,

Lease: Empire South Deep Unit Well No.15 (Federal Lease No.LC-061702)
Description: SW/4 NW/4, of Section 8, Township 18 South, Range 29 East, and,

Lease: Empire South Deep Unit Well No.16 (Federal Lease No.LC-028712)

all in Eddy County, New Mexico.

Production shall be allocated to each lease by separately metering production from each lease prior to commingling .

FURTHER: The operator shall notify the Artesia District Office of the Division upon implementation of the commingling process.


