Tract 6, Well No. 13 Drickey Queen Sand Unit





Dear Mr. Motter:

Reference is made to your application to the Oil Conservation Commission which seeks administrative approval for the conversion of a well in Tract 13, Well No. 7, SE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 33, Township 13 South, Range 31 East to a water injection well, dated August 22, 1960. No information whatsoever is available to this office with regard to the construction of the well and the method of injection to be employed in the event this application is approved. In the absence of such information, this office must oppose the granting of the application until information is submitted which will show that injection through this well will not constitute a threat to any fresh waters which may exist in the area. If it is convenient for you to submit to me a detailed diagrammatic sketch showing the casing and cementing program employed in the original construction of this well and a statement as to whether or not tubing and packer will be used in the injection, I will be able to determine what the position of this office should be and notify both you and the Secretary-Director of the Commission at an early date.
