
Pursuant to the provisions of Paragraph 2 of Order # R-1533, Chaco Oil Company hereby requests permission to drill Injection Well No. I-13 at an unorthodox location in the Red Mountain Field, McKinley County, New Mexico.

The Proposed Location for Well # I-13 is 452 feet from the North Line and 2740 feet from the east line of Section 29, Township 20 North, Range 9 West, N.M.P.M., McKinley County, New Mexico.

This injection well is necessitated by the fact that well #I-4, which was intended to be an injection well, proved to be oil-productive, and well #I-13 is intended to extend the producing area of the pool and to replace well #I-4 in the peripheral pattern.

Thank you for your response of 7 November, 1961, regarding my request for an unorthodox location for Injection Well I-13, in the Red Mountain Field, McKinley County, New Mexico.

Well #I-4 will be given a new designation as a producing well, probably as well #5, and the proper forms will be filed with the Commission.

The latest production test of Well # I-4 was made on 1 October, 1961. The well produced 27 barrels of oil and 10 barrels of water in a 24-hour period.
