ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-2064, Newmont Oil Company has made application to the Commission on May 28, 1962, for permission to expand its Square Lake Water Flood Project in the Square Lake Pool, Eddy County, New Mexico.

NOW, on this 12th day of June, 1962, the Secretary-Director finds:


1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Order No. R-2064.
4. That the proposed injection wells are eligible for conversion to water injection after July 1, 1962, under the terms of Order No. R-2064.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Newmont Oil Company, be and the same is hereby authorized to inject water into the Lower Grayburg and Upper San Andres formations through the following described wells for purposes of secondary recovery after July 1, 1962:

- Texas Trading Federal Well No. 6 located in the NE/4 SE/4 of Section 33
- Texas Trading Federal Well No. 5 located in the NE/4 SW/4 of Section 33
- Texas Trading Federal Well No. 4 located in the SW/4 NE/4 of Section 33
- Texas Crude Johnson Well No. 6 located in the NE/4 NE/4 of Section 33,
- Texas Crude Johnson Well No. 16 located in the SW/4 SE/4 of Section 33 and Carper Federal "B" Well No. 3 located in the SW/4 NW/4 of Section 34, all in Township 16 South, Range 31 East, NMPM.

Done at Santa Fe, New Mexico, on the day and year hereinabove designated.
