ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Rock Island Oil & Refining Company, Inc., has made application to the Commission on January 18, 1963, for permission to expand its Wills (Yates) Water Flood Project in the Rhodes Pool, Lea County, New Mexico.

NOW, on this 8th day of February, 1963, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Rule 701.
4. That the proposed injection well is eligible for conversion to water injection under the terms of Rule 701.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.


IT IS THEREFORE ORDERED:

That the applicant, Rock Island Oil & Refining Company, Inc., be and the same is hereby authorized to inject water into the Yates formation through the following described well for purposes of secondary recovery, to wit:

Wills "B" Well No. 1 located in Lot 1 of Section 34,  
Township 26 South, Range 37 East, NMPM.
