ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701 E-5, Neil Wills et al has made application to the Commission on May 15, 1963, for permission to expand its Russell Water Flood Project in the Russell Pool, Eddy County, New Mexico.

NOW, on this 31st day of May, 1963, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Rule No. 701 E-5.
4. That the proposed injection wells are eligible for conversion to water injection under the terms of Rule No. 701 E-5.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Neil Wills et al, be and the same is hereby authorized to inject water into the Yates formation through wells to be drilled at the following unorthodox locations for purposes of secondary recovery:


