ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Union Oil Company of California has made application to the Commission on September 8, 1963, for permission to expand its South Caprock Queen Unit Water Flood Project in the Caprock-Queen Pool, Chaves County, New Mexico.

NOW, on this 23rd day of September, 1963, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Rule 701.
4. That the proposed wells are eligible for conversion to water injection under the terms of Rule 701.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Union Oil Company of California, be and the same is hereby authorized to inject water into the Queen formation through the following described wells for purposes of secondary recovery, to wit:

- Tract 7A Well No. 15-33 located in the SW/4 SE/4 of Section 33
- Tract 70 Well No. 11-33 located in the NE/4 SW/4 of Section 33, and
- Tract 69A Well No. 5-33 located in the SW/4 NW/4 of Section 33 all in Township 14 South, Range 31 East, NMPM,
- Tract 23 Well No. 4-29 located in the NW/4 NW/4 of Section 29,
- Tract 39 Well No. 8-30 located in the SE/4 NE/4 of Section 30,
- Tract 40 Well No. 6-29 located in the SE/4 NW/4 of Section 29,
- Tract 29 Well No. 7-20 located in the SW/4 NE/4 of Section 20,
- Tract 51 Well No. 14-20 located in the SE/4 SW/4 of Section 20, and Tract 21 Well No. 11-X-20 located in the NE/4 SW/4 of Section 20 all in Township 15 South, Range 31 East, NMPM.

PROVIDED HOWEVER, That applicant shall inject water through tubing with packers set just above the perforations or open hole of the above described wells.
