Gentlemen:

Cities Service Oil Company, operator of the Drickey Queen Sand Unit, Caprock Queen Pool, Chaves County, New Mexico, requests administrative approval as provided in Rule 701 and Order R 1128-B for the conversion of the following well to Injection:

Tract 2 Well No. 1, Unit L, Section 15, T-14S, R-31E

This well is offset by producing wells which have experienced response from the waterflood. Form C-116 is included showing tests before and after stimulation. The proposed injection well is located on a pattern previously established in the Caprock Queen Pool, results of which have indicated a thorough and efficient sweep of oil by the injected water.

The injection well will be equipped with cement lined tubing and a packer to prevent possible contamination of fresh water zones in the event of a casing leak. The attached schematic diagram indicates the size of casing, setting depth, amounts of cement used, tops of cement, total depths and other pertinent data. Water injection will be into the Queen formation at approximately 400 barrels per day. The source of the injection fluid is the Ogalalla fresh water sand and the supply wells are located in Section 24-14S-31E, Chaves County and Sections 19, 29 and 30-14S-32E, Lea County, New Mexico.

A copy of this application, along with all attachments, has been sent to each offset operator and to the New Mexico State Engineer.

No well will be assigned an allowable greater than the amount of oil produced on the official test.

During gas-oil ratio test, each well shall be produced at a rate not exceeding the top unit allowable for the pool in which well is located by more than 25 percent. Operator is encouraged to take advantage of this 25 percent tolerance in order that well can be assigned increased allowables when authorized by the Commission.

Gas volumes must be reported in MCF measured at a pressure base of 15.025 psia and a temperature of 60 degrees F. Specific gravity base will be 0.60.




