ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, J. R. Cone has made application to the Commission on August 27, 1964, for permission to expand its Cone Jalmat Yates Pool Unit Water Flood Project in the Jalmat Pool, Lea County, New Mexico.

NOW, on this 22nd day of September, 1964, the Secretary-Director finds:


1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Rule 701.
4. That the proposed injection wells are eligible for conversion to water injection under the terms of Rule 701.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED: That the applicant, J. R. Cone, be and the same is hereby authorized to inject water into the Yates formation through the following described wells for purposes of secondary recovery, to wit:

Unit Well No. 1-11 located in the SE/4 SE/4 of Section 13, Unit Well No. 1-10 located in the SE/4 NW/4 of Section 24, Unit Well No. 2-2 located in the NW/4 NE/4 of Section 24, and Unit Well No. 3-4 located in the SE/4 NE/4 of Section 24, all in Township 22 South, Range 35 East, NMPM,

PROVIDED HOWEVER, That applicant shall inject water through tubing with packers set well below the top of the cement surrounding production casing in the above-described wells.

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
