ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Mobil Oil Corporation has made application to the Commission on May 1, 1967, for permission to expand its Vacuum Water Flood Project in the Vacuum Grayburg-San Andres Pool, Lea County, New Mexico.

NOW, on this 9th day of May, 1967, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That the State Engineer has waived objection and inasmuch as the proposed injection well is an interior well, the waiting period prescribed by Rule 701 may be dispensed with at this time.
4. That the proposed injection well is eligible for conversion to water injection under the terms of Rule 701.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Mobil Oil Corporation, be and the same is hereby authorized to inject water into the Grayburg-San Andres formation through the following described well for purposes of secondary recovery, to wit:

State Bridges Well No. 107 located in the SW/4 NW/4 of
Section 13, Township 17 South, Range 34 East, NMPM.

PROVIDED HOWEVER, That the applicant shall inject water through tubing with a packer set at approximately 4550 feet in the production casing of said well.

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
