ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-2403, Continental Oil Company has made application to the Commission on August 7, 1967, for permission to expand its MCA Unit Water Flood Project in the Maljamar Pool, Lea County, New Mexico.

NOW, on this 27th day of August, 1967, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Order No. R-2403.
4. That the proposed injection wells are eligible for conversion to water injection under the terms of Order No. R-2403.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Continental Oil Company, be and the same is hereby authorized to inject water into the Grayburg-San Andres formation through the following described wells for purposes of secondary recovery, to wit:

MCA Unit Well No. 127 located in Unit D of Section 25,
MCA Unit Well No. 131 located in Unit B of Section 25,
MCA Unit Well No. 137 located in Unit H of Section 25,
MCA Unit Well No. 139 located in Unit F of Section 25,
MCA Unit Well No. 190 located in Unit L of Section 25,
MCA Unit Well No. 194 located in Unit J of Section 25,
all in Township 17 South, Range 32 East, NMPM,
MCA Unit Well No. 133 located in Unit D of Section 30,
MCA Unit Well No. 198 located in Unit L of Section 30,
both in Township 17 South, Range 33 East, NMPM.

PROVIDED HOWEVER, That applicant shall inject water through tubing with packers set well below the top of the cement

surrounding the production casing in the above-described wells.

IT IS FURTHER ORDERED; That the applicant is hereby authorized to discontinue gas injection into the following described wells:

MCA Unit Well No. 128 located in Unit F of Section 25, MCA Unit Well No. 130 located in Unit G of Section 25, MCA Unit Well No. 193 located in Unit J of Section 25, all in Township 17 South, Range 32 East, NMPM,

and to cease water injection into the following wells:

MCA Unit Well No. 195 located in Unit I, Section 25, Township 17 South, Range 32 East, NMPM, and MCA Unit Well No. 197 located in Unit L, Section 30, Township 17 South, Range 33 East, NMPM.
