Gentlemen:

In accordance with Order No. R-2969, concerning the Swearingen Waterflood Project in Eddy County, New Mexico, Atlantic Richfield Company requests approval to expand the project by drilling an additional well to be used for water injection. The location of this proposed well (see attached plat) is 750' FSL and 2060' FWL, Section 14, Township 18 South, Range 31 East. It is planned to set and cement 4-1/2" casing and inject into the Queen formation through perforations at approximately 3400 feet. The injection is planned to be down 2-3/8" O.D. tubing with a packer set less than 100' above the perforations. The injection rate is expected to be about 300 BWPD at a surface pressure of 1700 psig. Fluid treated to prevent corrosion will be placed in the annulus.

In the past several months the known productive limits of the Swearingen Project have been extended by the drilling and completion of Swearingen "B" No. 6 as a producer and the recent wash down and completion of the Panco Federal No. 1 (see attached plat). The completion of these two wells as producers resulted in the subject location being offset in all four directions by producers. Therefore, the drilling and completion of the proposed injection well will sweep secondary reserves to existing producers that would not otherwise recover these reserves. The completion of the proposed well as an injector will conform with the present five-spot pattern and will be an extension of this pattern.

We would appreciate approval of this request at your earliest convenience. Please forward a copy of your approval letter to the United States Geological Survey. Upon receipt of your approval we will submit the proper drilling permits for approval.


