Newmont Oil Company hereby request administrative approval to convert to water injection, the West Loco Hills Unit Tract 1 Well No. 1, Unit Letter D, 330' FNL and 330' FWL of Section 7, Township 18S, Range 30E, in the West Loco Hills Grayburg No. 4 Sand Unit, Eddy County, New Mexico.


This well is in the Buffer Zone of the Newmont Operated Project which was established by Order No. R-2166 and amended under Order No. R-2178-C (Case 2805) dated 6-11-63. The location of the well and other pertinent data are shown on the plat and diagrammatic sketches hereto attached in compliance with the requirements as set forth by the above reference orders.

It is planned to inject produced water from the West Loco Hills Unit and/or fresh water purchased from the Yucca Water Company at an estimated rate of 1000 BPD. The casing will be pressure tested to 300 psi above the maximum anticipated surface pressure.

A copy of this application has been mailed to the State Engineer. Newmont Oil Company as the only operator offsetting the proposed injection well, requests the fifteen day waiting period be waived.


