ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Allied Chemical Corporation has made application to the Commission on April 26, 1972, for permission to expand its Union Texas Langlie Jal Water Flood Project in the Jalmat and Langlie-Mattix Pools, Lea County, New Mexico.

NOW, on this 11th day of May, 1972, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Rule 701.
4. That the proposed injection well is eligible for conversion to water injection under the terms of Rule 701.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Allied Chemical Corporation, be and the same is hereby authorized to inject water into the Seven Rivers and Queen formations through the following described well for purposes of secondary recovery, to wit:

Langlie-Jal Unit Well No. 21 located in Unit J of Section 32, Township 24 South, Range 37 East, NMPM.

PROVIDED HOWEVER, that the applicant shall inject water through tubing with a packer set at approximately 3250 feet in said well.

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
