Gentlemen:

We respectfully request administrative approval to expand our Northeast Maljamar Waterflood Project as provided in Order No. R-3154, dated November 28, 1966. This expansion will include the conversion of Phillips Petroleum Company's Phillips-State "E" Well No. 12 (M-10-17S-33E) to water injection service in the Maljamar Grayburg sands, and expansion of the project area to encompass offsetting proration units which include E/2 SE/4 Section 9, SW/4 Section 10, and N/2 NW/4 Section 15, all T-17-S, R-33-E, Lea County. Current oil producing wells within this expansion area are Phillips Petroleum Company's Phillips-State "E" Nos. 11 (I-9-17S-33E) and 13 (D-15-17S-33E). A combination of produced and fresh water make-up will be injected into Well No. 12 at an anticipated rate of 300 BWPD at 2700 psi.

We attach an area plat showing the current project area, as well as the proposed expansion area with the subject wells located thereon, a diagrammatical sketch of the casing and completion design of Well No. 12, copies of letters requesting waivers from offset operators, and an electric log with pertinent data thereon.

Your early consideration of this proposal subject to the receipt of the requested waivers or of the 15-day protest waiting period will be appreciated.




