Gentlemen:

Application for Expansion of South Eunice Unit Waterflood

Order No. R-4068 authorized the installation and operation of the waterflood project in the South Eunice Pool within the area of the South Eunice Unit the agreement for which was approved by Order No. R-4067. Since those orders were entered a Lease Line Agreement has been negotiated between the South Eunice Unit, the Seven Rivers Queen Unit, operated by Atlantic Richfield Company, and Texas Pacific Oil Company for cooperative waterflooding across common boundaries. This agreement called for the substitution of Well No. 62 located in Unit O Section 33 in place of Well No. 63 which is located in Unit N of said Section 33.

In addition, Continental has drilled and completed for water injection Wells Nos. 64 and 65 located in Unit A of Section 33 and O of Section 28, respectively. The proposed injection wells are shown with the red triangles on the attached plat. We also attach schematic diagrams to show the manner in which each of the wells will be equipped for injection. The annulus above the packer will be filled with inert fluid and the surface connections equipped so that pressure will be readily detected.

It is respectfully requested that authority be given to inject water into Wells 62, 64 and 65 as described above.





SEU WATERFLOOD




