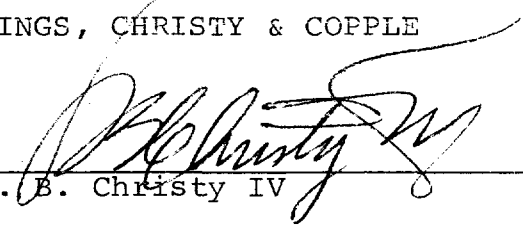
All of the injection fluid to be used is purchased from the City of Carlsbad Water Company; this purchased water is produced from the Ogallala formation.

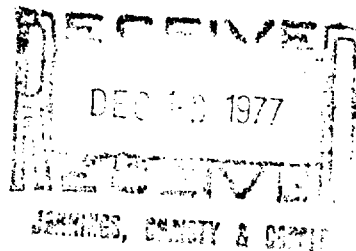
