In the event any drilling activity occurs in the subject area of review, Devon Energy Corporation will notify the supervisor of the Artesia District office and the Division office. An administrative review of the permit will be conducted, and the status of the permit will be determined.

All other provisions and conditions of WFX-719 and Division Rules 706 and 1120 shall remain in full force and effect.


