Providing that all conditions contained in the order remain the same and there are no wells drilled in the area of review, the expiration date of the WFX-728 is hereby extended to April 15, 1999.

In the event any drilling activity occurs in the subject area of review, F & M Oil and Gas Company will notify the supervisor of the Hobbs District office and the Division office. An administrative review of the permit will be conducted, and the status of the permit will be determined.

All other provisions and conditions of WFX-728 and Division Rules 706 and 1120 shall remain in full force and effect.


