ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-3033, Coastal States Gas Producing Company has made application to the Commission on December 12, 1966, for permission to expand its Flying "M" Pressure Maintenance Project in the Flying "M"-San Andres Pool, Lea County, New Mexico.

NOW, on this 27th day of December, 1966, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Order No. R-3033.
4. That the proposed injection well is eligible for conversion to water injection under the terms of Order No. R-3033.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:


That the applicant, Coastal States Gas Producing Company, be and the same is hereby authorized to inject water into the San Andres formation through the following-described well for purposes of secondary recovery, to wit:

FM "B" Well No. 3, located in Unit F of Section 17, Township 9 South, Range 33 East, NMPM, Lea County, New Mexico

PROVIDED HOWEVER, That applicant shall inject water through tubing with a packer set at approximately 4385 feet in the 4 1/2-inch casing.

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
