Gentlemen:

The sixth revision of the Niobrara-Greenhorn participating area for the Canada Ojitos unit agreement, Rio Arriba County, New Mexico, was approved on March 12, 1970, by the Acting Oil and Gas Supervisor, U. S. Geological Survey, effective December 1, 1968.

The sixth revision of the Niobrara-Greenhorn participating area adds 960 acres described as the E $\frac{1}{2}$  sec. 21 and all of sec. 22, T. 25 N., R. 1 W., N.M.P.M., and is based on the completion of unit well No. A-22 in the NE $\frac{1}{4}$ NE $\frac{1}{4}$  sec. 22 as a paying well pursuant to the terms of the unit agreement.

Copies of the approved application are being distributed to the Federal offices involved and one copy is returned herewith. You are requested to furnish all interested parties with appropriate evidence of this approval.

OUT IN COMMISSION ORDER R-3401

Gentlemen:

As provided in the Canada Ojitos Unit Operating Agreement under Article 13, application for the sixth expansion was made by the Unit Operator and recently approved by the acting oil and gas supervisor. The area included in this expansion covers Section 22 and the east half of Section 21 in Township 25 North, Range 1 West.

Enclosed herewith you will find Canada Ojitos Unit Exhibit "A" showing the boundary of sixth expansion to participating area. Canada Ojitos Unit no. 12 (A-22) producing oil well is located in the  $NE\frac{1}{4}NE\frac{1}{4}$  of Section 22.

Also enclosed herewith is a xerox copy of the letter requesting Commission approval for the expansion of pressure maintainance project area dated December 19, 1968. The plat referred to therein is also enclosed. Commission approval of this request was not granted because Section 22 was not within the participating area.

This request was for an enlargement consisting of Section 22; however, since the U.S.G.S. has subsequently approved the expansion of the participating area to include the  $W\frac{1}{2}$  of Section 21 plus Section 22, we believe the project area should likewise be enlarged to include this acreage.






Thank you for your order dated June 17, 1970, approving our application for expansion of the Canada Ojitos Unit Pressure Maintenance Project Area.
