



Please remit a Ten (\$10.00) Dollar filing fee.





Gentlemen:

The Commissioner of Public Lands approved the captioned Communitization on October 30, 1962, effective as of September 1, 1961. This well which was drilled in the SW/4SE/4 of Section 28, Township 15 South, Range 32 East, was communitized for the Wolfcamp formation and has now ceased producing communitized substances. Therefore, your Communitization Agreement has been terminated effective as of November 19, 1970, which is the date you intended to plug and abandon the well.
