ADMINISTRATIVE ORDER

1. That application has been filed in due form.
2. That satisfactory information has been provided that there are no other offset operators.
3. That the proposed expansion of the above referenced pressure maintenance project will not cause waste nor impair correlative rights.

That the applicant, Amoco Production Company, be and the same is hereby authorized to expand its South Hobbs Grayburg-San Andres Pressure Maintenance Project by addition of lands in Township 18 South, Range 38 East, NMPM, Lea County, New Mexico, described as follows:


SE/4 SE/4 of Section 33 and
