ADMINISTRATIVE ORDER OF THE OIL CONSERVATION DIVISION

Under the provisions of Order No. R-6199, Shell Oil Company has made application to the Division on August 8, 1980, for permission to expand its North Hobbs Grayburg San Andres Unit Pressure Maintenance Project in the Hobbs Grayburg San Andres Pool, Lea County, New Mexico.

Now, on this 26th day of August, 1980, the Division Director finds:

- 1. That application has been filed in due form.
- 2. That the proposed injection $_{\text{Wells are}}$ eligible for conversion to water injection under the terms of Order No. R-6199.
- 3. That the proposed expansion of the above referenced pressure maintenance project will not cause waste nor impair correlative rights.
 - 4. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Shell Oil Company, be and the same is hereby authorized to inject water into the Grayburg-San Andres formation through plastic-lined tubing set in a packer, to wit:

PROVIDED HOWEVER, that the subject wells shall be governed by orders set out by Order R-6199.

That the operator shall notify the supervisor of the Division's Hobbs District Office before injection is commenced through said well.

That the operator shall immediately notify the Supervisor of the Division's Hobbs District Office of the failure of the tubing, casing, or packer in said well or the leakage of water from or around said well and shall take such steps as may be timely or necessary to correct such failure or leakage.
