ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701 (c) Sinclair Oil & Gas Company made application to the New Mexico Oil Conservation Commission on November 15, 1962, for permission to complete for salt water disposal its Argo Thomlinson Well No. 1, located in Unit K of Section 14, Township 18 South, Range 38 East, NMPM, Lea County, New Mexico.

The Secretary-Director finds:

- (1) That application has been duly filed under the provisions of Rule 701 (c) of the Commission Rules and Regulations;
- (2) That satisfactory information has been provided that all offset operators, surface owners and the New Mexico State Engineer Office have been duly notified; and
- (3) That the applicant has presented satisfactory evidence that all requirements prescribed in Rule 701 (c) will be met.
- (4) That no objections have been received within the waiting period as prescribed by said rule.

IT IS THEREFORE ORDERED:

That the applicant herein, Sinclair Oil & Gas Company, is hereby authorized to complete its Argo Thomlinson Well No. 1, located in Unit K of Section 14, Township 18 South, Range 38 East, NMPM, Lea County, New Mexico, in such a manner as to permit the injection of salt water into the San Andres formation from approximately 4,877 feet to approximately 6500 feet through tubing with packer set at approximately 4800 feet.

IT IS FURTHER ORDERED:

That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order, after Notice and Hearing the Commission may terminate the authority hereby granted in the interests of conservation. That applicant shall submit monthly reports of its disposal operation in accordance with Rules 704 and 1119 of the Commission Rules and Regulations.
