

Gentlemen:

Reclassification of Stevens B No. 8, Unit A, Section 12, T-23S, R-36E, Lea County, to Salt Water Disposal from Injection status

Conoco respectfully requests reinstatement of Administrative order SWD No. 197 reclassifying the subject well as a salt water disposal well. This reinstatement will thus suspend Division Order No. 3539 classifying the subject well as a secondary recovery injector.

The subject well had been previously earmarked as an injector in the proposed King Langlie Mattix Unit operated by Texaco (formerly Getty) and therefore was reclassified from a salt water disposal to a secondary recovery injector. Conoco has not participated in the as yet unformed unit and has no plans at the present to do so. Thus, Conoco would like to reinstate Administrative Order SWD No. 197 for the subject well.

We would dispose of produced water from the Stevens B lease only and we do not produce any offsetting wells (Nos. 6, 9, 10, 13). We do not anticipate producing the offsetting wells at this point in time. The Stevens B No. 8 would be disposing of water in the Langlie Mattix Seven Rivers Queen pool, the horizon in which the well is now completed.
