Yates Petroleum Corporation respectfully requests your approval to amend SWD-498 to extend the perforated interval within the Bone Spring formation. The Order currently authorizes perforations from 8134 feet to 8555 feet. We are requesting authorization to perforate from 6945 to 8742, which is still within the Bone Spring formation.

I contacted Mitchell Energy, the only other operator within one-half mile of the Shooting Star SWD. Mr. Dan Tuffley, engineer, had no objection to the amendment. Mitchell's well, the State "JR" #1, located in P-11-18S-35E, Lea County, has its cement top at 6406 feet.
