

STIMULATION PROGRAM
(Section IX, Form C-108)

The proposed injection well was originally drilled in April, 1994 as a Morrow test. Thirteen and three-eighths inch casing was set at 455' with 640 sacks of cement which was brought back to surface. Nine and five-eighths inch casing was set at 4520' and cemented with 400 sacks with a top of cement at 600'. Seven inch casing was set at 9450' with two stages of cement totaling 1260 sacks with the DV tool set at 6981 and the top of cement being 4350'. Bridge plugs have been set at various depths below 7,000'. It is proposed to drill out the top plug and clean out well bore to 7711'. Squeeze cement into perforations at 7338 to 7508. Drill out cement and test. If test okay, drill out bridge plugs to 9303'. Perforate well over interval from 8644' to 8960'. Clean up injection interval with 1000 gallons of 15% NE acid if needed.

LOGGING AND TESTING DATA
(Section X, Form C-108)

The Electric Log run on the subject well on April 26, 1971 is included in Section VIII as part of Exhibit II. The DST taken at our proposed injection depth is also shown in Exhibit II of Section VIII.

FRESH WATER ANALYSIS

(Section XI, Form C-108)

As indicated by Section VIII there were no records found on fresh water wells in this area. Our search of the area found one water well in Section 35. The well was abandoned. This well is located in the NW/4 of the NE/4 of Section 35. We asked the owner about the well and he indicated the well had not been used in years because "the water was no good". Also, there is a stock water well located in the NW/4 of the NW/4 of Section 22. This well is about 120' in depth. A copy of the water analysis taken from this well is attached as Exhibit A. There are no water wells within the two mile radius of the proposed well. Additional information and discussion is contained in the attached letter identified as Exhibit B.

The above referenced water disposal unit lies within the recently extended Roswell Underground Water Basin. On Feb 8, 1993 the New Mexico Engineer issued Special Order Number 147. The preamble states, among other things:

Par. III Whereas, the Roswell Underground Water Basin boundaries, as presently defined, do not include certain adjacent areas which are a part of the underground water basin having reasonably ascertainable boundaries and in which new appropriations of water might impair existing water rights.

Par. IV Whereas the surface and underground waters in some areas within the boundaries of this basin may be interrelated.


The two mile area of review contains in excess of 200 wells drilled from a few feet to approximately 11,000 feet deep. There is no record of any fresh or potable waters being tested from any of these wells. A search of records in the State Engineers office indicates there are no water wells in the $\frac{1}{2}$ mile area of review. A physical search of the land surface reveals no evidence of potable water except the commercial fresh water pipeline used by ranchers in the area.

Examination of sample logs and electric logs reveals that surface rocks consist of Upper Permian Quartermaster red shales and siltstones. The Rustler formation consisting of anhydrite and dolomite is present from 150 to 300 feet below the surface and the Salado salt occurs immediately below that.

The lack of any evidence of naturally occurring potable water and the nature of the surface and subsurface sediments within the area of review suggest that paragraphs III and IV of the order are not valid presumptions for the extension of the Roswell Underground Water Basin to this area.

We thereby respectfully request your granting the above referenced administrative approval to dispose of produced waters into the Pennsylvanian formation at a depth of 8640 to 8960 feet.




