
Dear Mr. Stone:


Dear Mr. Glenn:




*Re: Activation of Division Order SWD 611*

Referenced is made to Division Order SWD-611 which authorized the use of your Big George Well No.3 for purposes of salt water disposal. It was discovered that my staff released the permit prematurely when an objection to the application was filed, at which time, we were informed that public notice had been delayed. The objection was therefore considered valid and Order SWD-611 was placed in suspension pending settlement of the objection. 

Reference is made to your recent request, on behalf of Mack Energy Corporation, for an extension period in which to implement operations as permitted by Division Order SWD-611. My staff has considered the request and we feel an extension is justified at this time.

Division Order SWD-611 is hereby extended for a period of six months. The permit will expire on April 30, 1997. If injection has not been implemented by this date, the authority for injection shall terminate ipso facto. If this occurs, your client may be required to submit additional data and other justification to have Division Order SWD-611 reinstated.

Gentlemen:


We would like to request on behalf of Mack Energy Corporation, applicant under the above-captioned administrative order, an extension of time to commence injection operations thereunder for the following reason:

Commencement of drilling operations for this well were planned to commence in the fall of 1996. However, due to an increase in oil and gas prices, demand for drilling rigs has exceeded supply, making it difficult to obtain a rig for the drilling of this salt water disposal well.

Therefore, the undersigned requests an extension of 120 days for good cause shown pursuant to the Administrative Order of the Division dated November 27, 1995.
