Maralo, Inc., has not commenced injection operations in its proposed saltwater disposal well, Barnes 20 Well No. 1, Unit C of Section 20, Township 9 South, Range 35 East, N.M.P.M., Lea County, New Mexico. We believe that the injection authority granted by the above captioned Order terminates one year from January 22, 1997, unless Maralo, Inc., seeks an extension of said authority.

We request on behalf of Dean Kinsolving, in his capacity as general partner of Kinsolving & Kinsolving, that should any request be received for an extension of the above captioned authority, before consideration of such a request for extension, you provide us with notice and an opportunity for our client to be heard. Based upon the information available to us, we are of the opinion that our client was not accorded due process prior to granting the above captioned Order.

Please provide me with a photocopy of Maralo, Inc.'s, complete Application for Saltwater Disposal Well in the above captioned proceeding, including photocopies of all notices given by Maralo, Inc., through newspapers, letters, or any other method, to members of the public in connection with its Application. At the time of forwarding the requested copies, please send me a Statement for the photocopy expense and we will remit upon receipt of same.
