Notice is hereby given that Clayton Williams Energy, Inc., 6 Desta Drive, Suite 3000, Midland, Texas 79705, has made an Application for Authorization to Inject with the Oil Conservation Division of the State of New Mexico Energy and Minerals Department. The intention of the applicant is to convert the New Mexico State "EO" Com #1 well and dispose of produced water into the Cisco formation, 8750'-8950'. The well is located 1980' FNL and 660' FWL of Section 20, Township 17 South, Range 29 East, in Eddy County, New Mexico. The expected maximum injection rate will be 8000 barrels per day and the expected maximum injection pressure is 1754 PSIG. 


