Amtex Energy, Inc. hereby request Oil Conservation Division approval to commingle the production from the 2 wells listed below, which are on the same lease, into the same production tank battery. Pertinent well information for your consideration is as follows:

The production battery is on the same location with the Record Well No.1. Amtex request to lay a flowline from the Record Well No.5 to the production battery for the Record Well No.1 to surface commingle the production from these two wells. Additionally, the record lease ownership is common under the entire lease with royalty, overriding royalty and working interest owners being the same in both wells.
