RE: Surface Commingling of Dale H. Parke Leases

Gentlemen:

Premier Oil and Gas respectfully request approval to commingle crude oil produced from two separate leases. Premier proposes to commingle Paddock production from the Dale H. Parke "C" Federal lease (LC-029020-C) with the paddock production from the Dale H. Parke "A" Tract 1 Federal lease (NM-0467930). Production from the Dale H. Parke "C" wells will be pumped via flowlines to the Dale H. Parke "C" tank battery located at approximately 330' FSL and 990' FEL in Section 15 of T-17S, R-30E. At the "C" battery, the natural gas produced will be separated, and at this point, sold to a gas purchaser. The produced water will also be separated and sent to be disposed of. The crude oil will then be metered through a Lact Unit at the "C" battery and transferred to the Dale H. Parke "A" Tract 1 battery. The Dale H. Parke "A" Tract 1 is an existing battery located at 990' FNL and 1650' FWL in Section 22 of T-17S, R-30E. The crude oil from the Parke "C" battery will be pumped directly into the Parke "A" battery storage tank. The commingled crude will then be sold via a Lact Unit at the Parke "A" battery. Tank battery site diagrams, as well as a plat of the transfer and flowline routes is attached to aid in your review of the application. The Parke "A" battery sells approximately 745 barrels of oil per day with an average corrected gravity of 38 degrees by commingling production from the Parke "C" battery. The production volume should increase by approximately 80 barrels per day, but will gradually decline over time as the wells age. The gravity is expected to remain the same due to the close proximity of the commingled wells as well as being sourced from the same formation. Daily production will be



calculated at the Parke "C" battery and then subtracted from the total production at the Parke "A" battery to arrive at the production attributable to the Parke "A" battery. Both batteries have test facilities to enable us to test individual wells. Both Lact Units will be tested on a regular basis.

Due to current marketing, arrangements in place at the Parke "A" battery, not offered at the Parke "C" battery, a great economic loss to all interest owners would result if commingling is not approved. Additionally, by relieving flowline pressures as soon as possible, you increase the proration volumes of these wells, both now and in their sunset years. An approval now will be invaluable when secondary operations begin on this lease. A similar application for commingling approval has been submitted to the Roswell office of the Bureau of Land Management. A copy of their decision will be forwarded to NMOCD upon receipt of such.
