Concerning the above referenced well, Conoco, Inc., anticipates drilling and completion of this well in the North Hardy-Strawn pool (Oil-96893). Conoco, Inc. is requesting permission to surface commingle the crude oil from this well at the SEMU Strawn battery, Section 25, T20S, R37E (Unit Letter G) under Commingling Order PLC-158. The State "25-A", Well #3, completed in July 2000 in the North Hardy Strawn pool, is also commingled at this battery. The ownership is not identical for the State "25-A", Well #3, State "25-A", Well #5 and SEMU wells going into this battery. Attached please see a listing of the ownership for the Tubb PA and the Strawn PA. Copies of this letter, the ownership summary and justification have been sent to each of the parties listed.





SEMUR Strawn/Tubb Proposed Commingling and Associated Meters





SEMU Strawn/Tubb Proposed Commingling and Associated Meters
