Dear Mr. Catanach:

On July 11, 1991 an order was issued for the above referenced Administrative Order. This order was the result of an application by Zia Energy, Inc. for approval to convert to salt water disposal the Simmons No. 2. The disposal formation was to be the San Andres formation. We requested approval for zones of porosity between 4456' to 5004'. The order was issued for zones from 4730' to 4910'.

We have been injecting into the zone from 4900' to 4910' for almost ten years. The wellhead injection pressure is presently near 800 psi, which is approaching the 946 psi limit approved by the order.

We request Administrative Approval to extend the injection interval to include zones of porosity from 4730' down to 5025'. We request approval from the Oil Conservation Division to add perforations from 4925' to 4940, from 4970' to 4976' and from 5000' to 5010'. The top of the Glorieta formation, as picked by Paul Kautz, is 5090'. There is a 35' dense zone between the base of porosity in the San Andres and the top of the Glorieta. Therefore, water injected into the San Andres will be confined to the San Andres formation.

We have sent a copy of this request for an amendment to Administrative Order SW-431 to the following Operators within the one-half mile radius of our Simmons No. 2-SWD: Wiser Oil Company, Arch Petroleum Inc., Texaco Exploration & Production, John H. Hendrix Corp., B.E.C. Corporation, Chevron USA, Inc., William B. Yarborough, ROC Energy, Inc. and the surface owner Wayne Henson. A copy of the advertisement which appeared in the Hobbs News Sun is also enclosed. Also enclosed is a copy of the certified mailing to each of these companies.




