We have derived the following information from your letter of application:


1. Meridian Oil, as operator, owns 100% working interest on both leases.

Dear Mr. Prando:

Meridian requests permission for off lease storage of the captioned well to the Federal "21" Battery located in Unit Letter K, Sec. 21, T18S, R33E, Lea County, NM, Lease No. NM-61605. Enclosed is a money order for \$30.00 to cover the application fee.

Plats are attached showing the location of the leases, well, and flow line.

The only lease involved in this request is the Tijeras State No. 1 in Unit Letter O, Sec. 21, T18S, R33E, Lea County, NM, Lease NM-64944.

The Tijeras State No. 1 produces from the South Corbin Wolfcamp Pool. A schematic diagram of the entire system is enclosed. We plan to add one tank at the Federal 21 Battery and completely separate the oil piping. The double LACT at the West Corbin Battery will be used to sell both leases. Production will be metered at the storage site.
