Dear Dick:

The Douglas No. 1 well located in unit J of Section 7, Township 19 South, Range 27 East will need a liquid stream gathering system to my North Lake McMillan No. 1 well located in unit J, Section 12, Township 19 South, Range 26 East, Eddy County, New Mexico. Separation of liquids and natural gas will be at the well site and no production will be commingled.

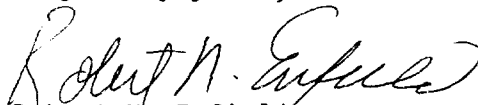
This off-lease storage is necessary as the well in unit J of Section 7 is in the Pecos River flood plain of the Lake McMillan reservoir and the Bureau of Reclamation requires that I put my batteries at an elevation of at least 3285.3. The location I have chosen for this off-lease storage is the closest point having the required elevation.

Attached hereto are two plats showing my liquid gathering system (in red) from Unit J, Section 7, T-19-S, R-27-E to the storage area located in Unit J Section 12, T-19-S, R-26-E.

It is requested that I be granted administrative approval to have off-lease storage.

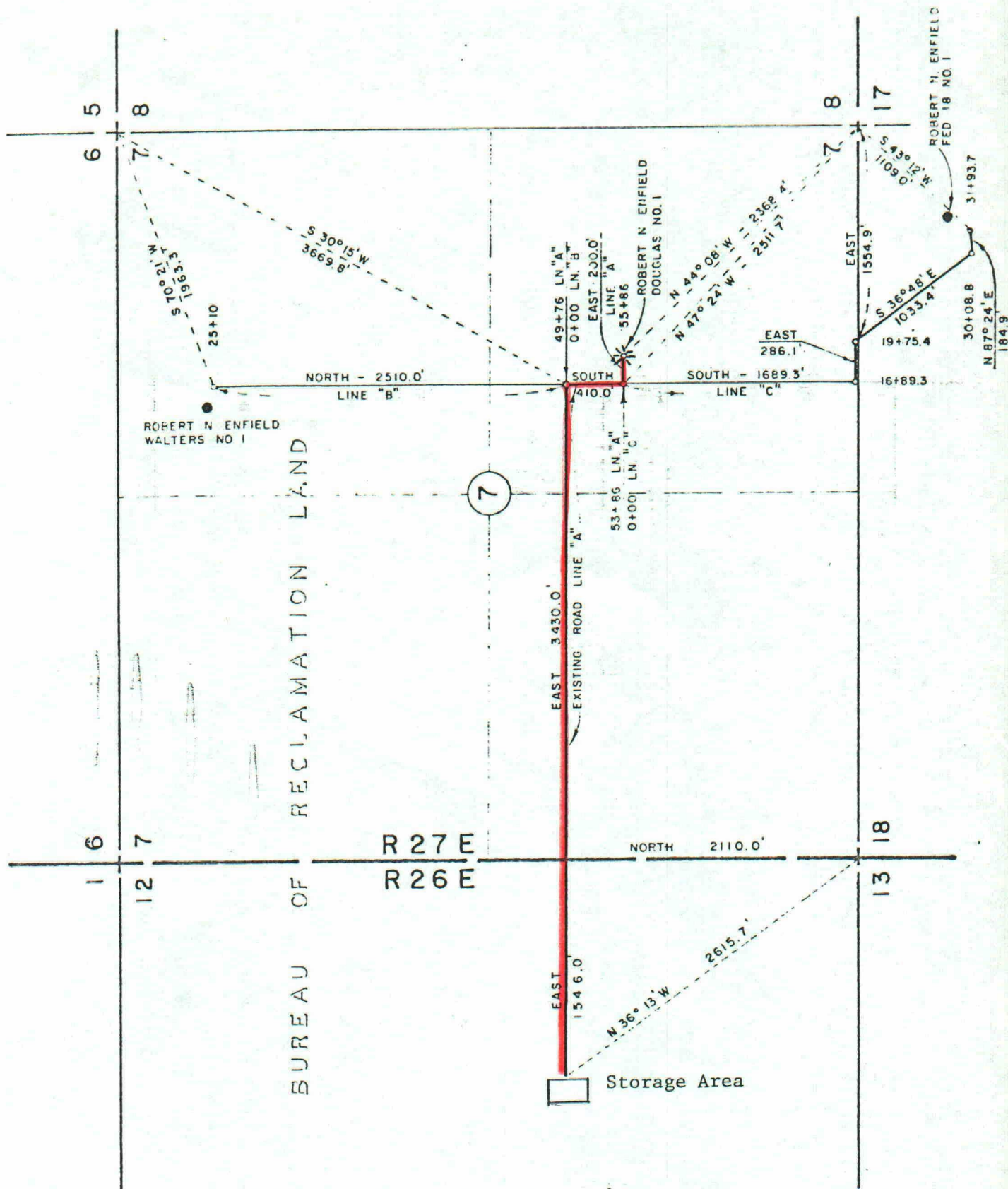

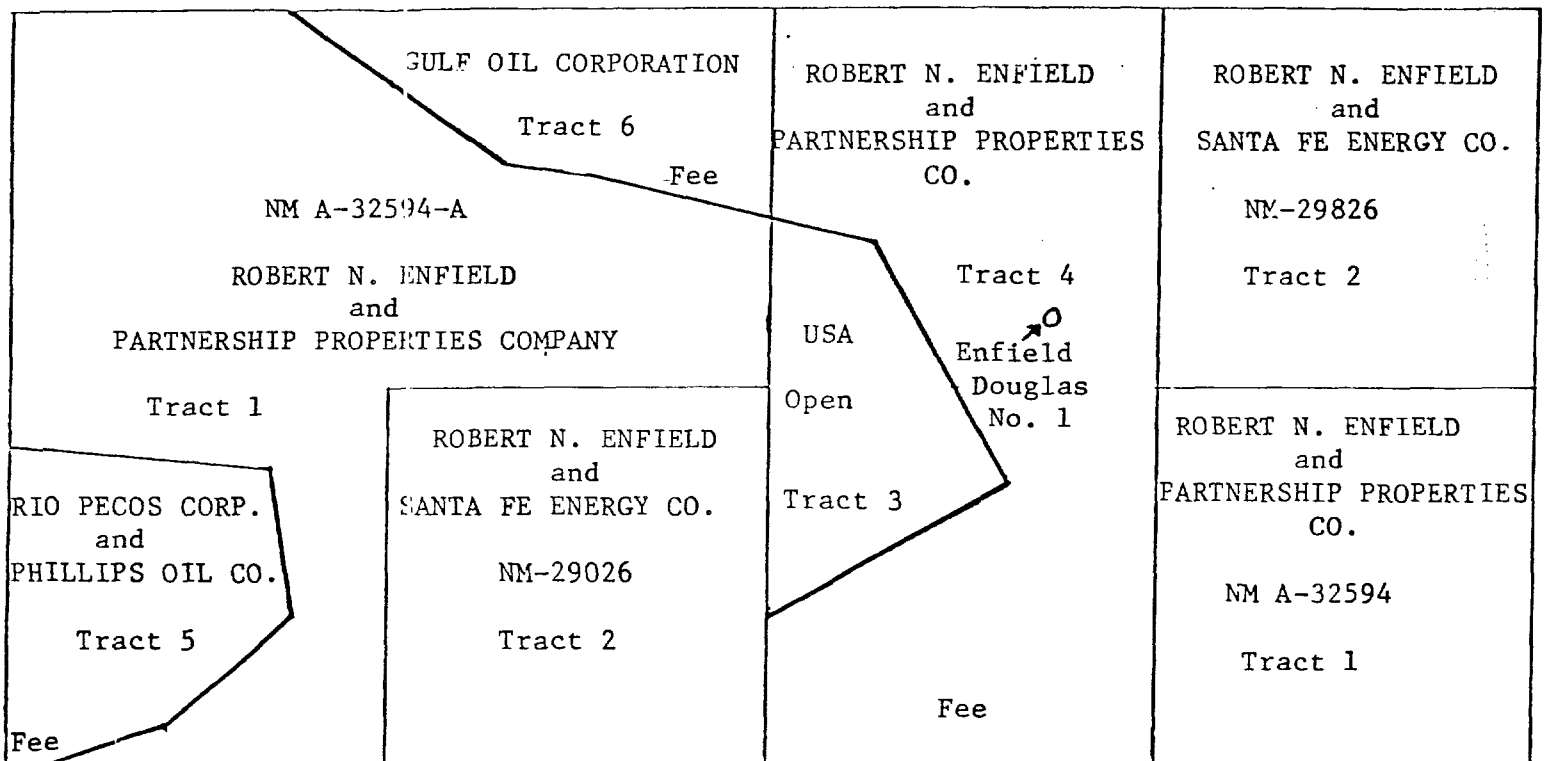
