

Gentlemen:

Pursuant to my telephone conversation with Mr. Floyd Prando, William N. Beach requests permission under Rule 309C of New Mexico Energy and Minerals Department to allow off lease storage for the Beach #1 Latham-State, located in SE/4 NW/4 Section 25, T-16-S, R-28-E, Eddy County, New Mexico. This request is made due to the location of well in old lake bed and flooding of the location. If tank battery is put on this location, oil transports and other oilfield vehicles would not be able to have access in and out of lease during rainy weather.

If approved, there will be no commingling or intercommunication of handling of the oil or gas between the Beach #1 Latham-State and the Beach #1 Hinkle-State. Said tank battery will be located on Beach Hinkle-State lease located in the SE/4 SW/4 Section 25, T-16-S, R-28-E, Eddy County, New Mexico. Tank battery will be 350 feet west of Beach #1 Hinkle-State.



I hereby give my approval of the re-location of the tank battery in accordance with Rule 309C of the N.M. Energy and Minerals Department.



