Description: NW/4 Section 28, Township 19 South, Range 25 East, NMPM


all in Eddy County, New Mexico.

Yates Petroleum Corporation respectfully requests administrative approval to add the Lorene ANN #1, located 810' FNL & 660' FWL (NWNW) of Section 28-T19S-R25E, Eddy County, New Mexico (a new well - fee land) to existing Order No. CTB-~~379~~, for surface commingling, lease commingling, off lease sales and measurement. The production from the Lorene ANN #1 will be transported prior to measurement to a common tank battery located at the Hooper AMP #1 location. A map labeled, Attachment I, is enclosed for your information.

The purpose of this off-lease storage and surface commingling is to reduce operation costs for storage and treating, thereby extending the economic life of each well. Without approval for utilizing existing batteries on adjacent leases, it will become necessary to build separate facilities for each well. This will greatly increase costs and shorten the economic life of the well(s).

Because working interests for the wells are different, oil from each of the wells will be measured by positive displacement, temperature compensated metering equipment prior to surface commingling. Gas from the wells will also be metered separately. This metering will ensure that all production from each of the wells is equitably accounted for with no significant effect on your revenue. The production from the same production zone which is the Canyon.






