Dear Mr. Chumbley:

This letter acknowledges the receipt of your administrative application dated July 20, 2001, to convert the Durango "15" State Com No. 1 located in Section 15, Township 17 South, Range 29 East, NMPM, Eddy County, New Mexico, to a disposal well. The Division received your application on July 23, 2001.

Our preliminary review indicates that the information provided in the application is not sufficient to process the administrative order. The following information is necessary:

- a) **Is the Delta Wing Federal Well No. 1 the only well within the "Area of Review" that penetrates the proposed injection interval. Your application is not clear on this point.**
- b) **Copy of the publication notice.**

Since the submitted information is insufficient to review, the application was **Ruled Incomplete** on July 25, 2001. Please submit the above stated information by August 1, 2001.

The Division cannot proceed with your application until the required information is submitted. Upon receipt, the division will continue to process your application. The additional information can be faxed, or mailed to the Division. If the necessary information is not submitted, your application will be returned to you.
