Description: SE/4 NW/4, SW/4 NW/4, Section 14, T-17-S, R-30-E

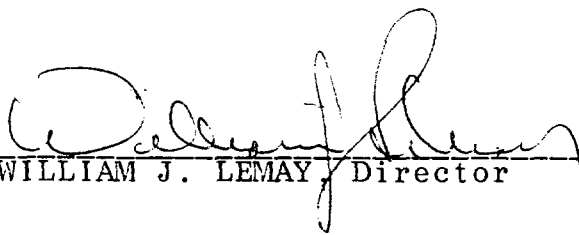
Both in Eddy County, New Mexico

Production shall be allocated to each lease by well tests. (If this method or the subtraction method is to be authorized, all commingled production must be of identical ownership: working interest, royalty interest, and overriding royalty interest.)

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: This amendment authorizes the additional commingling of the Gissler "B" Well No. 26 located in the SE/4 NW/4 of Section 14.

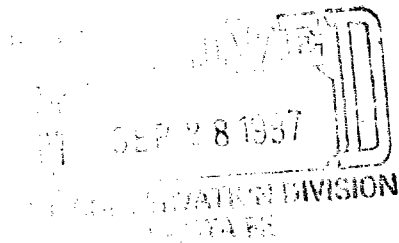

Dear Mr. LeMay:

We are currently completing our Gissler "B" #26 (NM 074939) in the Grayburg Jackson field. This well is the second lease well and is located in the SE/4 of the NW/4 of Section 14, T17S, R30E, NMPM, Eddy Co., New Mexico. We are asking for an exception to Rule 309-A to permit us to commingle the production from our Gissler "B" #26 with the production from our Gissler "B" lease (NM 2748) through an amendment to commingling order CTB-323, adding this well.

All production is from the same common source of supply (Grayburg Jackson) and all ownership of the two leases, including working interest ownership, royalty interest ownership and overriding royalty interest ownership is identical. Adequate facilities (portable well tester) will be provided to determine allocated production from each lease. All parties have been notified by certified mail of our intent to commingle production from these two leases.
